**“Turbines of Polish Economy 2016” is a ranking of small and medium enterprises, created based on revenues. In this year’s edition, Polski Holding Nieruchomości S.A. came in first among 150 SMEs, with H1 2016 revenue of PLN 88.6 million, which means an increase of over 21% compared to PLN 73.0 million year-on-year.**
