## **Management Board's recommendation regarding dividend for 2014**

Current report No. 15/2015 of May 13, 2015

### **Legal basis:**

Article 56.1.2 of the Act on Public Offering – current and periodical information

The Management Board of Polski Holding Nieruchomości S.A. (the “Company”) hereby informs that on May 13, 2015, it adopted a resolution on filing an application with the General Meeting of Shareholders on distributing the Company's profit for year ended on December 31, 2014. in the amount of PLN 120,813,141.13 by assigning:

1. the amount of PLN 60,664,307.60 of profit for a dividend for shareholders, i.e. PLN 1.30 per share,
2. the amount of PLN 60,148,833.53 of profit for supplementary capital.

The Management Board before making a decision concerning the dividend for 2014, was guided by the intention, declared in PHN S.A. strategy, to share the growth of the Company's value with its shareholders in the form of dividend, and took account of the Group's present financial standing and planned cash flows, including the expected investment plans and the possibility of obtaining financing for their implementation.

The Company's Management Board proposed that August 19, 2015 be set as dividend record date and August 26, 2015 as dividend payment date.

### **Legal basis:**

Article 38.1.11 of the Regulation of Minister of Finance of February 19, 2009 on current and periodical information published by issuers of securities and the conditions of recognizing information required by the regulations of non-member

states as equivalent (Journal of Laws 2009 No. 33, item 259, as amended).
