On Friday, August 26, there was an official hand over to the “Bursztynowa Przystań” Children’s Hospice in Gdynia of PLN 75,000 collected during the first “PHN-GDYNIA VIP RACING 2016” charity regatta. Wojciech Szczurek, the President of the City of Gdynia, was a guest of honor during the event.

Fifteen key players in the Polish economy participated who in the “PHN-GDYNIA VIP RACING 2016” charity regatta organized by Polski Holding Nieruchomości SA in early July were present at the event. Each team (ENEA SA, EuRoPol GAZ SA, Full Colour Sp. z o.o., Grupa LOTOS SA, Hillwood Polska Sp. z o.o., Kancelaria Głuchowski Siemiątkowski Zwara, Korporacja Budowlana Doraco Sp. z o.o., PZL-Świdnik SA, OLIVIA BUSINESS CENTRE, Polski Holding Nieruchomości SA, Polskie Górnictwo Naftowe i Gazownictwo SA, PROFBUD Sp. z o.o., Profesjonalna Liga Piłki Siatkowej SA, PricewaterhouseCoopers Polska Sp. z o.o., Totalizator Sportowy Sp. z o.o.) donated PLN 5,000 to the Gdynia hospice. The money will help ensure proper care to the children the hospice is helping.
